What is the mobile phone base station deployment industry code?

The Code replaces the C564:2020 Mobile Phone Base Station Deployment Industry Code. The Code supplements the requirements already imposed on Carriers under the existing legislative scheme by requiring them to consult with local communities on the site selection, design and operation of mobile phone base stations.

What is a radio base station reconfiguration procedure?

This procedure outlines the application procedure to be followed by the mobile services operators (hereinafter called the "operators") for the reconfiguration of existing radio base stations NOT involving changes in the structural design and planning perspective of the parent building, and the change of land use.

Are mobile base station sites EME compliant?

The Radio Communications Licence Conditions (Apparatus Licence) Determination 2015 mandates that the operation of equipment does not exceed the general public exposure limit. All mobile base station sites are required to be approved for EME compliance. This process ensures the safety of the General Public.
