What are the import licensing requirements in Peru?

Several consumer goods in Peru are subject to import licensing requirements to ensure they meet safety and quality standards. These products, which include electronics, motor vehicles, and household appliances, must comply with local regulations before they are allowed into the country.

Why does Peru have strict import regulations?

As an active participant in global trade agreements, Peru adheres to strict import regulations to safeguard the health and safety of its citizens, protect the environment, and ensure that imported goods comply with local and international standards.

How long do you have to bring your household items to Peru?

However, you must bring your household items between 1 and 6 months after you entered the country into Peru. Only the tax is 12% of the customs value (not what you think your stuff is worth), which consists of the FOB value of the household goods plus the value of international freight and insurance.

Are You complying with Peru customs regulations?

Check the information below to be sure that you are complying with Peru customs regulations. Restricted to travellers 18 years and over. One of the following: or 250 grams of tobacco. 3 litres of liquor. Funds of US\$10,000 or its foreign equivalent and over must be declared.

The National Superintendence of Customs and Tax Administration (SUNAT) has released an official list of goods and items you can bring into Peru without paying taxes in 2025.
