When will Italy's new energy storage capacity procurement auctions take place? Terna's thinking ...The date is set. The first of Italy's new energy storage capacity procurement auctions (MACSE) will take place on September 30,2025,Terna's president for grid development strategies,Francesco Del Pizzo,has confirmed.

How will MACSE change energy storage requirements in Italy?

There are stark differences in energy storage requirements across Italy and MACSE procurement targets will adapt to these zonal needs. Most of the new utility-scale storage capacitycatalyzed by MACSE will be needed in Southern Italy and the islands,with 16.8 GWh in the South,13.6 GWh in Sicily, and 10.4 GWh in Sardinia.

Is the electricity storage capacity procurement mechanism compatible with EU plans? "MASE has approved the proposal for the regulation of the Electricity Storage Capacity Procurement Mechanism." In December 2023,the European Commission confirmed the framework was compatible with EU plansfor the development of new electricity storage capacity within its internal market.

Why did Italy postpone a battery auction?

Terna,Italy's transmission system operator,says they postponed the auction to September to increase competition,ensuring more authorised projects can participate. According to them,Italy is entering phase 2 for battery storage,shifting to a more competitive landscape where developers must compete for limited opportunities.
