Are plug-in solar panels illegal?

Since plug-in solar panels are not installed by a licensed electrician or signed off on by your utility company, they may actually be illegal in some areas. Plug-in solar panels violate many local utility codes because they feed electricity into a home circuit without dedicated shutoff and safety features.

Do building regulations apply to solar panels?

Where the property is in a conservation area, is a listed building or part of a World Heritage site for example, Permitted Developments will not apply and an application will have to be made to the Local Planning Authority. Building Regulations will always apply as solar panels significantly increase the weight of a roof.
